## **A Glance Over COVID -19 Vaccine and Conspiracy**

History shows that plagues and pandemics change the course of humanity permanently. Thousands of people die, civilizations end, economy collapses. Diseases often become too difficult to contain, posing a major challenge to the ruling governments across the world. Outbreak of infectious diseases along with wars, economic changes, and technological developments, have drastically shaped the world and our living environment. Perhaps the most infamous is the bubonic plague, which ravaged Europe for centuries. It led to the Black Death, the global pandemic which struck Europe and Asia in the mid-1300s.

However, viruses are the most common biological creatures on Earth. **Experts estimate there are many trillions  $10(1000*10)$  of them. (1)** They are molecular machines which depends on the cells of other organisms to survive and reproduce themselves. Overwhelmingly, viruses are harmless to humans, some can make you sick and some can even be fatal. They cannot function outside a host organism; therefore, they are often classified as non-living. Outside a cell, a virus wraps itself up into an independent particle called a

virion, being able to survive structurally intact in the environment for a certain. It can infect a suitable organism if one comes into contact.

Some viruses also have an outer envelope made of lipids, which are fatty organic molecules. The coronavirus that causes COVID-19 is one of these “enveloped” viruses. Soap can dissolve this fatty envelope, leading to the destruction of the whole virus particle. That is why washing your hands with soap is so effective.

### ***Plagues and viruses spread in the past:***

Since the outbreak of COVID-19, many false news and misinformation has been propagated such as a theory that every 100 years, a pandemic happens. “1720 — Plague; 1820 — Cholera outbreak; 1920 — Spanish flu; 2020 — coronavirus. At first glance, nothing seems impossible, but the accuracy with which these events precisely occurred, is just false and a made-up story.

Likewise, many false news and misinformation has been published by different organisations.

There are many plagues which spread in the history, including:

The plague (1720-1722) spread an infectious fever caused by a bacterium transmitted from rodents to humans by the bite of infected fleas, caused some of the worst pandemics in history.

Great Plague of Provence, or Great Plague of Marseille, killed as many as 126,000 people in southern France starting in 1720.

The first pandemic of cholera spread from Calcutta along the Ganges Delta in 1817, it killed millions.

During the 1854 Broad Street cholera outbreak in the Soho district of London transmitted by exposure to contaminated water.

Spanish flu — 1918-1919 - called “The Great Influenza” by modern historians.

The pandemic “was caused by an H1N1 virus with genes of avian origin. Although there is not universal consensus regarding where the virus

originated, it spread worldwide during 1918-1919,” according to the CDC. “In the United States, it was first identified in military personnel in spring 1918. It is estimated that about 500 million people or one-third of the world’s population became infected with this virus. The number of deaths was estimated to be at least 50 million worldwide with about 675,000 occurring in the United States. “It was called the Spanish flu “not because it originated in Spain but because it was World War I, and Spain was the only country being honest about the toll the pandemic took on the country,” according to a Washington Post article on the deadliest pandemic.

The Middle East respiratory syndrome coronavirus (MERS-CoV) that causes a severe lower respiratory tract infection in humans is now considered a pandemic threat to the Gulf region. Since its discovery in 2012, MERS-CoV has reached 23 countries affecting about 1100 people, including a dozen children, and claiming over 400 lives. Compared to SARS (severe acute respiratory syndrome), MERS-CoV appears to kill more people (40% versus 10%), more quickly, and is especially more severe in those with pre-existing medical conditions.

Coronavirus — 2019-2020: COVID-19 can be traced back at least to Dec. 31, 2019, when the government in Wuhan, China, confirmed that health authorities were treating dozens of cases of pneumonia from an unknown cause. Eight days later, China identified a new type of coronavirus. The first coronavirus case in the United States was confirmed on Jan. 21, 2020. The World Health Organization declared COVID-19 a pandemic on March 11, 2020, saying it is the first pandemic caused by a coronavirus.

The COVID-19 pandemic could be one of the most impactful events in our lifetime. That is because the direct and indirect impacts of COVID-19 are repeatedly being aired and publicised extraordinarily large. According to some experts’ conspiracy theory cannot be excluded, elucidated in this article under the sub-title of “*Conspiracy theory around the COVID -19*”.

***The indirect impact of COVID-19 people:***

The indirect impacts that result from the containment measures of shutting down public life leads to widespread sufferings, including higher unemployment, lower production, increasing rates of poverty. To properly

monitor the impact of the pandemic we would need metrics that are unfortunately not available: *the total number of deaths due to COVID-19 and the metrics that capture the many ways the pandemic indirectly impacts our lives. But the widely available data on confirmed cases only becomes meaningful when it can be interpreted considering how much a country is testing.* How can we make progress against the pandemic?

To answer these sorts of questions we need data. But data is not enough. This is especially true in this pandemic because even the best available data is far from perfect.

Even at this early stage of the pandemic we see exceptionally large differences between countries as the data shows. While some suffer terrible outbreaks, others have managed to contain rapid outbreaks or even prevented bad outbreaks entirely. It is possible to respond successfully to the pandemic.

To monitor the impact of the pandemic is helpful for two reasons. First, not everyone who died of COVID-19 is known to have died of that disease, for example when no test for the virus was conducted. And second, it captures the indirect mortality impact of the pandemic. The impact of the pandemic can overwhelm the healthcare system so that people die of other causes of death. Excess mortality is then a more comprehensive measure of the death count during the pandemic.

### **Conspiracy theory around the COVID -19:**

The work on conspiracy theories surprises most people every day. There seems general lack of trust in so many political and health institutions which were trusted for a long time,” says Dr Robin Canniford, Senior lecturer at the University of Melbourne.” As to why this is happening now, I would draw on the climate of fear that people are experiencing. people are particularly susceptible to conspiracy theories during heightened times of anxiety, he added.

But Dr Canniford adds that some of the questions raised by the public are fair and relevant. **“If we take the United Kingdom as an example, the SAGE Committee –the group of scientists who were put together to advise on the response to COVID-19 – remained a closed shop. Now the questions then immediately come about, well why can’t the public know who’s on a committee that’s making decisions about their livelihood?”**

“And when voters are witnessing a set of global leaders, many of whom themselves are promoting what we can only call conspiracy theory – promoting cures to the virus that rely on bleach for example – it is no wonder that people are searching for nefarious groups who they believe to be controlling them.”

“It is no wonder that there is a lack of trust at the moment and I think that is really fuelling and providing the fertile soil for this kind of conspiracy theory to grow.”

Moreover, at these times the risk for all patients, not just COVID-19 patients, can be much higher than normal. Patients who suffer from common cause of death - like cancers or cardiovascular diseases – might no longer be able to access their regular care. The rate of mortality in the nursing homes and age care centres are much higher. And others might postpone seeing a doctor because there are afraid to get infected with COVID-19 and thereby miss a diagnosis. Therefore, the fatality which happens is not related to COVID-19 only. That is why people are left in dark not to have access to accurate data, and just rely on the media reports.

Moreover, we consider the size of population, on the surface, it does not make much sense for us to compare huge countries like China or the US with small countries like Taiwan or Australia. According to new statistics released there are 20, 281,691 Coronavirus cases around the world, of which 739,785 deaths and 13, 205, 974 recovered. Based on those figures the death rate is 3.65 % worldwide. The causes of death can be different including from the direct and indirect impact if COVUD-19.

He was saying, “This vaccine should be tried on animals in the National Parks. President Museveni has sanctioned its use on Ugandans in exchange for money to finance his war in the Congo,” he declared, amid wild applause. He lost his position, but the companies made billions of dollars. Hundreds of people died as adults of the vaccines trial. The same scenario seems to be repeated in a different fashion in 2020.
